Convention Delegate Certification Form (the YELLOW form - DUE DATE: MARCH 15th)

WHEREAS, Chapter II, Section 12, Supreme Constitution, provides that the State Council shall consist of two representatives of each of the subordinate councils within the State, and it is beneficial that each subordinate council in good standing have two representatives at the State Council Convention meeting each year.

NOW, THEREFORE, BE IT RESOLVED, that each subordinate council in the Wisconsin Jurisdiction of the Knights of Columbus in good standing at the time of the 2026 State Council Meeting shall be entitled to have reimbursed two Delegates who attend said State Council meeting at the rate established by the Supreme Council, **for the distance necessarily traveled from the city in which their council is located to the convention and return**, said expenses to be paid directly to said Council.

Delegates:

Council shall have two (2) Delegates

Delegates must be the Grand Knight and a Past Grand Knight.

Alternates:

Council shall have two (2) Alternates.

Alternates can be any Third Degree member of the Council.

The **DELEGATES CERTIFICATION** included in the forms packet is used to identify your Delegates and Alternates. It should be completed and returned to the State Office immediately after your council elects its Delegates and Alternates.

We will do this in part by listing the names of all Brothers who have passed away during the period of March 1, 2025 through February 28, 2026 in the annual Convention Book. To assure the names of your Council's Deceased Members are listed in the convention book the form must be mailed to the State Office NO LATER THAN MARCH 15th! Two Memoriam Cards are enclosed in this mailing. You may request extra cards from the Wisconsin State Knights of Columbus Office if needed. 

Supreme Convention

DELEGATES TO THE 144th SUPREME CONVENTION

Denver Colorado, AUGUST 4-6, 2026

Wisconsin is allowed ten delegates to the Supreme Convention. The State Deputy and the Immediate Past State Deputy automatically serve as the first two delegates. The remaining eight delegates are selected by the vote of those delegates attending the State Convention.

Supreme Council reimburses delegates per diem at \$400 per day for 3 days and mileage at \$0.30 per mile one way.

ONLY SEATED DELEGATES CAN MAKE NOMINATIONS AND HAVE THE PRIVILEGE OF A VOTE AT THE CONVENTION; ALTHOUGH NON-DELEGATES CAN BE NOMINATED. We would like to remind you that previous delegates to the Supreme Convention should not seek a nomination in order that other members be given a similar opportunity to serve as a Supreme Delegate. The Delegates to this State Convention should be made aware of this Knight's accomplishments by the nomination speech given on his behalf. The person selected should be a Knight who has been extraordinary in promoting Charity, Unity, Fraternity and Patriotism in the Knights of Columbus.

Hospitality Rooms

Hospitality rooms may be permitted under the following conditions:

1. The room shall be sponsored by a council only with the Grand Knight of said council assuming full responsibility for any damage or costs incurred.
2. The Grand Knight of the sponsoring council shall abide by the rules and regulations of the facility wherein the hospitality room is located as to the purchase and furnishing of food and beverages and also as to any rules set by the Convention Chairman with the approval of the State Deputy.
3. No hospitality room may be open during daily Convention Sessions, Convention Mass or Convention Banquet. They may be open after the banquet and shall close by 11:30 pm. or as dictated by the hotel, whichever is earlier.
4. Any hospitality room may be closed by order of the State Deputy for breach of any rules or conditions as set forth by him.

Hospitality Rooms (continued)

The State Secretary shall be furnished, by Noon, on the first day of the Convention, prior to the opening of the Convention, the names of all councils sponsoring hospitality rooms, the room number, and the name of the person in charge. It is the responsibility of those councils which desire to host a hospitality room to have it registered by that time with the State Secretary.

The State Secretary will give a printed copy of the rules regarding the hospitality rooms to the persons designated as being in charge thereof. Such printed copy of the rules may also be mailed to all Councils and Delegates with the regular mailing notice prior to the Convention.
